A free trolley begins at 11 am and will be available to transport vendors back to their vehicles at the conclusion of the market at 12 pm. **Vendors are not permitted to break down any earlier than 12 pm. No vendors are permitted to park on either level of the Riverwalk Landing parking terrace.**

At the conclusion of the Market at 12 pm, vendors are required to break down their product and equipment and clear the area no later than 1 hour after the close of the market.
