Artists are invited to submit their work to participate in Yorktown's Tenth Annual **Art at the River** juried art show on Sunday, May 7, 2023, from 10AM to 4PM to be held at Riverwalk Landing, 331 Water Street, Yorktown, VA. Yorktown is located on the banks of the York River, part of Virginia's Historic Triangle of Williamsburg, Jamestown, and Yorktown.

All applicants must be 18 years of age or older.

Artists awarded Best of Show and 1<sup>st</sup> Place in the 2022 show will be exempt from the application fee of \$25, but must send in application.

**In celebration of Art at the River's Tenth Annual Show**, artists who have participated in five or more of the last nine shows will be exempt from the application fee of \$25, but must send in application.

Set-up for **Art at the River** will be on Sunday between 7AM and 9AM. Artists must provide a 10x10 tent and tables/racks necessary to display art. Show will be open to the public from 10AM to 4PM. Prizes totaling over \$3,000 will be awarded.

## ELIGIBLE WORKS

**All items displayed or sold must fall into “Fine Arts” or “Original Handcrafts” categories. All works must be original creations of the artist in the following categories:** Paintings (Watercolors, Oils, Acrylics, Tempera, Pastels, etc), Pen & Ink Drawings, Photography, Woodwork, Pottery, Glass, Metalwork, Fabric, Jewelry, Fiber, Basketry, Graphics, Mixed Media.

**ACCEPTABLE TO SHOW:** All artwork must be conceived and executed solely by the exhibiting artist. All ceramics, glass, jewelry, or metal pieces must be hand built, thrown, blown, cut, strung, cast, fused or otherwise created by the artist. Jewelry components must feature handmade beads or natural stones. All photographic prints must be signed and numbered. All artwork must be for sale. **All artists must be present during the entire show.**

**UNACCEPTABLE TO SHOW:** Shell crafts, decoupage and decal crafts; works made using commercial molds or kits; dried flower arrangements; and works utilizing materials from endangered species; commercial or mass-produced items. **Sales persons and/or agents hired to operate booths are not acceptable.**

**SPACE FEES - \$100 regular 10x10 space  
\$125 corner/end 10x10 space**

The Space Fee will be due upon acceptance into the Show. No tent sharing will be allowed. Corner space assignments will be on a “first-paid” basis. Notification of space location will be provided prior to the event.
